I. Terms and Definitions

1. **Organizer:** The Slovak Investment and Trade Development Agency (SARIO)
2. **Event:** SARIO Business Day IN REGIONS
3. **Venue:** Košice, Slovak Republic

4. **Date:** May 28, 2026
5. **Registration:** from April 27 to May 18, 2026
6. **Objective:** The main goal of the event is to facilitate bilateral negotiations (B2B) with potential partners, to bring information about new business and development opportunities, effective solutions for business development, including the possibility of consulting with professional partners. The event is primarily intended for companies from the Košice region

7. **Slovak Participant:** Slovak business entity established in the Slovak republic - registered in the matchmaking program for the bilateral meetings
8. **Foreign Participant:** business entity from abroad - registered in the matchmaking program for the bilateral meetings
9. **Matchmaking Program:** individual selection of partners in the period **from May 19 – May 24, 2026** in order to ensure bilateral negotiations according to the schedule on a pre-agreed platform

III. Registration for Participation and Conditions

1. The participation in the Event is voluntary
2. Any physical or law entity who has interest in presenting of his/her production and holding active negotiations with the potential foreign and domestic partners in order to establish mutual economic cooperation shall be the Slovak participant under the following condition: the entity shall be established in the Slovak Republic
3. Any physical or law entity who has interest in holding active negotiations with the participating business entities in order to create cooperation relations leading into buying the production output or services or in forming a Joint Venture shall be foreign participant
4. For successful registration complete the Registration Form at the SARIO web site engaged to the event and settle the registration fee according to the price list. The final invoice will be issued by the Organiser upon the event. A maximum of three persons per company can register for the event
5. Each Participant shall provide true data which will be afterwards used for the communication
6. In the period from **May 19 – May 24, 2026 until 12PM CET** (matchmaking program) registered participants will choose their partners for B2B negotiations themselves. Organisers are not responsible for the selection of partners
7. The insertion into the Matchmaking Program will be confirmed upon the payment of the fee according to the article III/4
8. Any objections regarding the Participant's payment shall be submitted not later than 14 days upon the receipt of the invoice
