CANCELLATION POLICY

- **In case the participant cancels the participation in writing through matchmaking@sario.sk till May 18, 2026, paid registration fee will be returned in full.**
- **In case the participant cancels the participation in writing through matchmaking@sario.sk in the period from May 19 to May 24, 2026, only 40% of paid total amount will be returned due to administration costs to SARIO resulting from registration of the participant. If the registration fee has not been paid by registered participant yet and participant cancels the participation in writing through matchmaking@sario.sk in the period from May 19 to May 24, 2026, SARIO has a legal right to the full amount of the registration fee reduced by 40%.**
